

# 1.20 Release notes

**Welcome to the uEducateUs 1.20 release.**

*These release notes are formatted in such a way so as to allow the different user types to easily find the issues that are relevant to them. For example, if you are a **parent**, you only need to look in the **Parents** category to find all issues that affect you.*

The focus of this release was; Change requests raised by schools, various improvements to the useability of permission slips and improvements to semester reporting useability.

We encourage your feedback, as this feedback continues to help drive the direction and content of our release cycles. The result being, a better and more usable application for all users.

## Parents

No issues directly impacting **Parent** user types have been identified in the release.

## Teachers

### Improvements

- [CR-578] - Admins and Teachers can now print permission slips for individual students or a selected number of students, rather than only being able to print the slips for all students.
- [CR-811] - Permission Slips **Equipment** Useability improvements; Several improvements to the way Equipment is categorised, added, removed, edited and managed have been implemented.

### Issues

- [CR-911] - Permission Slips > Risk Management useability improvements; Risks that have been set to **All Events**, can now be edited or removed from future permission slips.

## Students

No issues directly impacting **Student** user types have been identified in the release.

## Administrators

### Improvements

- [CR-25] - Admins can now add a text summary to Newsletters, as well as a link to a website (as some schools publish their newsletters to a website and wish to link to it).
- [CR-164] - Administrators now have the ability to view all the available timeslots for a **class** or **teacher** at a single glance, rather than having to click on individual time periods for each interview.

- [CR-578] - Admins and Teachers can now print permission slips for individual students or a selected number of students, rather than only being able to print the slips for all students.
- [CR-720] - Permission slips useability improvements; easier access to the Consent/Revoke, Make Payment and Edit Payment functionality.
- [CR-748] - Permission slips useability improvements; Admins can now edit a full or partial payment.
- [CR-942] – Reporting useability improvements; The option for **Justified Alignment** has been added to the reporting module for reporting comments.
- [CR-1037] - Reporting useability improvements; The **Principal Comment box** has been added to the main **Mark Student page**. This makes it easier for the Principal's comments to be added to reports.
- [CR-1062] - Reporting useability improvements; Admins can now sort subjects for semester reports in any order they like, by using a simple drag and drop sort interface.
- [CR-1096] - Parent Teacher Interview update; Admins can no longer edit an interview 48 hours after the interview has concluded. Some schools were attempting to reuse concluded interviews, which was causing issues.
- [CR-349] - Entering Student Free events in the calendar no longer deletes attendance records for those days. A reminder prompt will be displayed to mark the attendance as per normal and enter the correct attendance code.
- [CR-811] - Permission Slips **Equipment** Useability improvements; Several improvements to the way Equipment is categorised, added, removed, edited and managed have been implemented.
- [CR-835] - Kiosk > Staff Sign-in and Sign-out useability improvement; The **Reason** field can now be hidden by Admin users so that it does not appear on the Staff Sign-in and Sign-out pages of the Kiosk application.

## Issues

- [CR-911] - Permission Slips > Risk Management useability improvements; Risks that have been set to **All Events** can now be edited or removed from future permission slips.
- [CR-950] – Resolved the HTTP ERROR 500 that was occurring when the **Student Absence Summary By Year Level** report was generated.
- [CR-975] – Resolved the issue relating to; not being able to specify a campus in the **Student Attendance** report.

[CR-546] - The ability for **Peer Review Comments** has been added to the end of term reports.
